This policy addresses the medical necessity of Dry Hydrotherapy.

Dry Hydrotherapy self-contained device such as a table or chair that combine massage, water and heat to apply using a water mattress that patient lies on.

### Criteria:

Dry Hydrotherapy is considered not medically necessary for any indication.

The Early and Periodic Screening, Diagnostic and Treatment (EPSDT) covers services, products, or procedures for children, if those items are determined to be medically necessary to "correct or ameliorate" (make better) a defect, physical or mental illness, or condition (health problem) identified through routine medical screening or examination, regardless of whether coverage for the same service or support is an optional or limited service under the state plan. Children enrolled in the FAMIS Program are not eligible for all EPSDT treatment services. All requests for authorization for the services described by this medical policy will be reviewed per EPSDT guidelines.
