All requests for authorization for the services described by this medical policy will be reviewed per Early and Periodic Screening, Diagnostic and Treatment (EPSDT) guidelines. These services may be authorized under individual consideration for Medicaid members under the age of 21-years if the services are judged to be medically necessary to correct or ameliorate the member's condition. Purpose:

This policy addresses the medical necessity of - Sensory - Weighted Vest

Description & Definitions:

Sensory-Weight Vest is a wearable garment with the capability of holding weight, typically a vest with sewn internal pockets where small ½ or ¼ pound weights can be placed. The weight and compression delivered by the vest provides proprioceptive input using deep pressure to the muscles and joints which sends signals to the brain helping a person feel calm and focused.

Criteria:

A sensory-weighted vest is considered medically necessary for **all of the following**:

- Individual has a diagnosis of *Autism Spectrum disorder or Sensory Processing Disorder*
- Professional evaluation has been done by **1 or more** of the following:
 - Physical Therapist
 - Occupational Therapist
 - Psychologist

Sensory - Weighted Vest is considered not medically necessary for any use other than those indicated in clinical criteria.

The Early and Periodic Screening, Diagnostic and Treatment (EPSDT) covers services, products, or procedures for children, if those items are determined to be medically necessary to “correct or ameliorate” (make better) a defect, physical or mental illness, or condition (health problem) identified through routine medical screening or examination, regardless of whether coverage for the same service or support is an optional or limited service under the state plan. Children enrolled in the FAMIS Program are not eligible for all EPSDT treatment services.
