#### Approval Criteria – Coverage cannot be renewed

- □ Member is at least 18 years of age
- □ Requesting provider is an oncologist
- **G** For female members of reproductive potential, a negative pregnancy test has been confirmed
- □ Pre-treatment measurement of member's platelet level has been provided, and is <u>NOT</u> < 100,000 cells/mm<sup>3</sup>
- $\Box \quad \text{Member has adequate marrow cellularity of } > 15\%$
- $\Box$  Member's medical condition has < 25% involvement of lymphoma in bone marrow
- □ Requested medication will be used as a single agent following two doses of rituximab
- □ Member must meet <u>ONE</u> of the following:
  - □ Member has a diagnosis of relapsed or refractory, low-grade or follicular B-cell non-Hodgkin lymphoma (NHL), AND has not been previously treated with ibritumomab
  - □ Member has a diagnosis follicular NHL, previously untreated, AND has achieved a partial or complete response to first-line chemotherapy
- Provider will follow the recommended dosage per weight and timeline indication detailed in the table below:

Indication	Dose
All Indications	<ul> <li>Administer rituximab 250 mg/m<sup>2</sup> Day 1; repeat dose on Day 7, 8, or 9</li> <li>Within 4 hours of the second dose of rituximab, administer ibritumomab intravenously as follows: <ul> <li>Normal platelet count: 0.4 mCi/kg (14.8 MBq/kg)</li> <li>Relapsed/refractory &amp; platelets 100,000 – 149,000/mcL: 0.3 mCi/kg (11.1 MBq/kg)</li> </ul> </li> <li>Do not exceed the maximum dose of 32.0 mCi (11.84 MBq)</li> </ul>
