## Important reminders

#### Are you a new employee?

Sentara Health Plans understands the importance of maintaining your health without interruption when switching health plans. Your plans are designed to provide continuity of coverage and benefits. For a smooth transition, consider the following:

## If you currently receive obstetrics care, medical treatment, or have a procedure scheduled:

- Call your doctor's office and tell them your coverage will change to Sentara Health Plans.
- Confirm your doctors have sent clinical notes and authorizations to our Clinical Care Services team.

If you have scheduled a treatment that required authorization from your former health plan or if your prescriptions required prior authorization from your former health plan carrier:

 Sentara Health Plans will likely need to authorize this treatment and will work with you and your doctor to obtain necessary information.



Once you become a member, download the Sentara Health Plans mobile app from the App Store or Google Play. Register to safely and securely access important health information when you need it—at home, at the doctor, and even on the road.

## Find out if your doctor is in our network



To find providers, sign in to sentarahealthplans.com/members and visit *Find Doctors and Facilities*. You can search for a specific provider or facility by name or type,

and then filter your results by distance, languages, etc.. If your doctor practices in multiple locations throughout the Hampton Roads area, you can filter your search within a larger radius (such as 30 miles). The Sentara Health Plans database may list a different address for your doctor than the location you normally visit.
