## Denial Scenarios and Code Definitions

---

- Claims billed with H2016 and a DOS prior to 07/01/2021 will be denied D34 (DENY-CPT CODE DELETED/INVALID/NOT PROVIDED).
- There is an age requirement for H2016 code to be billed from 0 to age 13. Any claims billed with a member who is 14+ years of age will be denied D95 with a comment (CODE INAPPROPRIATE FOR AGE).
- Claims billed with H0035 and modifiers HA, HB, UG or U7 with DOS after 06/30/2021 will be denied D19P (DENY-INVALID MODIFIER FOR PROCEDURE CODE). Claims billed with H0035 and no modifiers prior to 07/01/2021 will also deny D19P (DENY-INVALID MODIFIER FOR PROCEDURE CODE).
- S9480 billed with a DOS before 07/01/2021 will be denied D34 (DENY-CPT CODE DELETED/INVALID/NOT PROVIDED).
- H0039 will deny D34 (DENY-CPT CODE DELETED/INVALID/NOT PROVIDED) if billed after 06/30/2021. H0040 billed with a DOS before 07/01/2021 will be denied D34 (DENY-CPT CODE DELETED/INVALID/NOT PROVIDED).
