This policy addresses the medical necessity for a Muscle Pain Detection Device (MPDD).

# **Description & Definitions:**

**Muscle Pain Detection Device (MPDD)** is a noninvasive electrical instrument that identifies pain by producing a contraction of a muscle mimic the movement that contribute to pain.

# Criteria:

Muscle Pain Detection Device (MPDD) is considered **not medically necessary** for uses other than those listed in the clinical criteria.

The Early and Periodic Screening, Diagnostic and Treatment (EPSDT) covers services, products, or procedures for children, if those items are determined to be medically necessary to "correct or ameliorate" (make better) a defect, physical or mental illness, or condition (health problem) identified through routine medical screening or examination, regardless of whether coverage for the same service or support is an optional or limited service under the state plan. Children enrolled in the FAMIS Program are not eligible for all EPSDT treatment services. All requests for authorization for the services described by this medical policy will be reviewed per EPSDT guidelines.
