All requests for authorization for the services described by this medical policy will be reviewed per Early and Periodic Screening, Diagnostic and Treatment (EPSDT) guidelines. These services may be authorized under individual consideration for Medicaid members under the age of 21-years if the services are judged to be medically necessary to correct or ameliorate the member's condition. Purpose:

This policy addresses Ovarian Vein Embolization.

Description & Definitions:

Ovarian Vein Embolization is a procedure used to help resolve a painful condition called pelvic congestion syndrome.

Criteria:

Ovarian Vein Embolization is considered medically necessary for pelvic congestion syndrome (PCS) with **all of the following**:

- Individual with a definitive diagnostic venography, computerized tomography (CT) scan, or Magnetic resonance imaging (MRI)
- Individual with failed trial of appropriate pharmacotherapy

Ovarian Vein Embolization is considered **not medically necessary** for any use other than those indicated in clinical criteria.

Medically necessary with criteria:

37241	Vascular embolization or occlusion, inclusive of all radiological supervision and interpretation, intraprocedural roadmapping, and imaging guidance necessary to complete the intervention; venous, other than hemorrhage (eg, congenital or acquired venous malformations, venous and capillary hemangiomas, varices, varicoceles)

Children enrolled in the FAMIS Program are not eligible for all EPSDT treatment services.
