All requests for authorization for the services described by this medical policy will be reviewed per Early and Periodic Screening, Diagnostic and Treatment (EPSDT) guidelines. These services may be authorized under individual consideration for Medicaid members under the age of 21-years if the services are judged to be medically necessary to correct or ameliorate the member's condition. This policy addresses the medical necessity of Mitochondrial antibody testing.

Description & Definitions:

Mitochondrial antibody (eq. M2) testing for either celiac disease or primary biliary cholangitis (primary biliary cirrhosis)

Criteria:

Mitochondrial Antibody Testing is considered medically necessary for all of the following:

Primary Biliary Cholangitis

Mitochondrial Antibody Testing is considered **not medically necessary** for uses other than those listed in the clinical criteria, to include but not limited to:

The Early and Periodic Screening, Diagnostic and Treatment (EPSDT) covers services, products, or procedures for children, if those items are determined to be medically necessary to "correct or ameliorate" (make better) a defect, physical or mental illness, or condition (health problem) identified through routine medical screening or examination, regardless of whether coverage for the same service or support is an optional or limited service under the state plan. Children enrolled in the FAMIS Program are not eligible for all EPSDT treatment services.
