PRENATAL AND POSTPARTUM CARE

Common Chart Deficiencies:

- Patients who delivered via C-section who are seen for incision check prior to 21 days after delivery and who do not return for another postpartum visit between 21 and 56 days after delivery.
- Ultrasound and lab results alone are not considered a visit; they must be linked to an office visit with an appropriate practitioner in order to count for this measure.
- A pap test alone does not count as a prenatal care visit.

Tips to Improve HEDIS rate:

- Use of a standardized prenatal flow sheet (such as the ACOG form) may be useful for documenting ongoing prenatal care and visits.
- Be careful to use the appropriate code for each service. Inaccurate coding on a claim, particularly when identifying date of delivery, can alter the results on this measure.

The percentage of deliveries of live births between November 6 of the year prior to the measurement year (2017) and November 5 of the measurement year (2018). The measure assesses:

- ⇒ Prenatal Care: The percentage of deliveries that received a prenatal visit as a member of the organization (Optima Health) in the first trimester <u>or</u> within 42 days of enrollment in the organization.
- ⇒ Postpartum Care: The percentage of deliveries that had a postpartum visit on or between 21 and 56 days after delivery.
- ⇒ Timeliness of Prenatal Care:

Documentation in the medical record must include a note indicating the date when the prenatal care visit occurred, and evidence of **one** of the following:

- A basic physical obstetrical examination that includes auscultation for fetal heart tone <u>or</u> pelvic exam with obstetric observations <u>or</u> measurement of fundus height.
- Evidence that a prenatal care procedure was performed, such as an obstetric screening panel, TORCH antibody panel or ultrasound of a pregnant uterus.
- Documentation of LMP or EDD in conjunction with either: prenatal risk assessment and counseling/education or Complete obstetrical history.

⇒ Postpartum Care:

Documentation in the medical record must include a note indicating the date when a postpartum visit occurred and **one** of the following:

- Notation of Postpartum Care
- Evaluation of weight, BP, breasts and abdomen
- Pelvic exam
