These services may be authorized under individual consideration for Medicaid members under the age of 21-years if the services are judged to be medically necessary to correct or ameliorate the member's condition. ### Purpose:

This policy addresses Equestrian Therapy (e.g., Hippotherapy).

### Description & Definitions:

Equestrian therapy (e.g., Hippotherapy) uses activities with horses to improve physical health.

### Criteria:

Equestrian therapy is considered medically necessary for **ALL** of the following:

- Treatment is being administered by a Licensed Therapist
- Treatment is part of a therapeutic program

Equestrian therapy is considered **not medically necessary** for any use other than those indicated in clinical criteria, to include but not limited to:

- Treating obesity

The Early and Periodic Screening, Diagnostic and Treatment (EPSDT) covers services, products, or procedures for children, if those items are determined to be medically necessary to "correct or ameliorate" (make better) a defect, physical or mental illness, or condition (health problem) identified through routine medical screening or examination, regardless of whether coverage for the same service or support is an optional or limited service under the state plan. Children enrolled in the FAMIS Program are not eligible for all EPSDT treatment services.
