What is the overall deductible ?	\$0/Individual or \$0/family VCUHS Network \$750/Individual or \$1,500/Family Optima Health PPO Network \$2,000/Individual or \$4,000/Family Out-of- Network	Generally, you must pay all of the costs from providers up to the deductible amount before this plan begins to pay. If you have other family members on the plan , each family member must meet their own individual deductible until the total amount of deductible expenses paid by all family members meets the overall family deductible .
Are there services covered before you meet your deductible ?	Yes. Prescription drugs , most services that require a copayment , preventive care , and a routine eye exam are covered before you meet your deductible .	This plan covers some items and services even if you haven't yet met the deductible amount. But a copayment or coinsurance may apply. For example this plan covers certain preventive services without cost sharing and before you meet your deductible . Are there other deductibles for specific services?	No.	You must pay all of the costs for these services up to the specific deductible amount before this plan begins to pay for these services .
What is the out-of-pocket limit for this plan ?	Medical: \$2,000/Individual or \$4,000/family VCUHS Network \$6,350/Individual or \$12,700/Family Optima Health PPO Network \$7,500/Individual or \$15,000/Family Out-of- Network Pharmacy: \$250/Individual or \$500/Family VCUHS Network \$500/Individual or \$1,000/Family Optima Health PPO Network .	The out-of-pocket limit is the most you could pay in a year for covered services. If you have other family members in this plan , they have to meet their own out-of-pocket limit until the overall family out-of-pocket limit has been met.
What is not included in the out-of-pocket limit ?	Premiums , balance-billed charges, and health care this plan doesn't cover.	Even though you pay these expenses, they don't count toward the out-of-pocket limit .
Will you pay less if you use a network provider ?	Yes. See http://www.optimahealth.com or call 1-800-229-1199.	You pay the least if you use a provider in Tier 1. You pay more if you use a provider in Tier 2. You will pay the most if you use an out-of-network provider , and you might receive a bill from a provider for the difference between the provider's charge and what your plan pays (balance billing).
