# Tips for New Members



### **Transitioning to Sentara Health Plans**

Sentara Health Plans understands the importance of maintaining your health without interruption when switching health plans. Your new plan is designed to provide continuity of coverage and benefits. For a smooth transition, consider the following before your new plan becomes effective on July 1.

# If you currently receive obstetrics care, medical treatment, or have a procedure scheduled:

- Call your doctor's office and tell them your coverage will change to Sentara Health Plans as of July 1.
- Confirm that your doctors have sent clinical notes and authorizations to the Sentara Health Plans clinical care services team in June.

# If you have scheduled a treatment that required authorization from your former health plan:

Sentara Health Plans will likely need to authorize this treatment and will work with you and your doctor to do so.

#### If your prescriptions required prior authorization from your former health plan carrier:

Sentara Health Plans will receive any existing pharmacy authorizations from your prior carrier. You will only need to obtain an authorization for new medications not already authorized.

Visit **sentarahealthplans.com/hrsd** and select *Find Doctors, Drugs and Facilities* to begin your search. You can search for a specific provider or facility by name or type and then filter your results by distance, language, etc.
